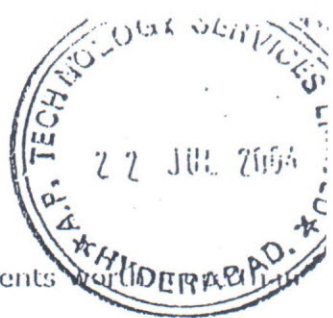

As per Government orders 1<sup>st</sup> read above APTS Ltd., is empowered to levy service charge up to 5% on the procurement value. In cases of lending partial service in the procurement process APTS Ltd., are allowed to levy charges based on the type of service rendered as detailed in the annexure to the orders in the reference 1<sup>st</sup> read above.

The Board of Directors of APTS, Ltd., in its 47<sup>th</sup> meeting resolved to propose downward revision of service charge for procurement orders of Rs.50.00 lakhs and above. Following were the proposals received:

Procurement Value	Service Charge	
	Existing	Proposed
1. Below Rs.50 lakhs	5%	5%
2. Rs.50 to 100 lakhs	5%	4%
3. Rs.100 lakhs and above	5%	3%

Government suggested exploring chances for further reduction and the Board of Directors of APTS Ltd., in its 53<sup>rd</sup> meeting held on 22.09.2003 discussed on the above and proposed the following rates:

Procurement Value	Service Charge	
	Existing	Proposed
1. Below Rs.50 lakhs	5%	5%
2. Rs.50 to 100 lakhs	5%	3.75%
3. Rs.100 lakhs and above	5%	2.50%

Government after careful consideration and detailed examination of the above hereby accept the service charge rates proposed by the Board of Directors of APTS Ltd., in its 53<sup>rd</sup> meeting held on 22.09.2003 and order that APTS Ltd., in continuation of the orders 1<sup>st</sup> read above shall levy charges on procurements made through APTS Ltd., where services rendered hitherto attracted a service charge of 5% at the following revised rates based on the value of procurement:

Procurement Value	Service Charge
1. Below Rs.50 lakhs	5%
2. Rs.50 to 100 lakhs	3.75%
3. Rs.100 lakhs and above	2.50%

1. All Departments and Public Sector Undertakings are, therefore, advised to follow these orders in matters relating to the procurement of computer hardware / software and office automation equipment.
