ORDER:

The Managing Director, Andhra Pradesh Technology Services Limited, has stated in his letter read above that Andhra Pradesh Technology Services Limited has been identified as Centralised Agency for procurement of Computer and Office Automation Equipment for all State Government Departments and Public Sector Undertakings / Corporations on the basis of requisitions received from them.

2. He has further stated that the Vendors after delivering the equipment are approaching the Andhra Pradesh Technology Services Limited for payments as per the agreements laid down. He has also stated that the payments from some of the Government Departments and Organizations are not forthcoming within the normal period of thirty days from the date of delivery even though orders were placed with the Vendors based on written indents from the user departments. In such cases payments made by Andhra Pradesh Technology Services Limited to the Vendors are getting locked up resulting in financial stringency. He has therefore requested the Governments, Undertakings and Corporations to make advance payments to a tune of 90 percent within sixty days of satisfactory completion of supply, so as to enable the Andhra Pradesh Technology Services Limited make payments to the Vendors as per the terms and conditions of the agreement.

3. The Government after careful consideration accept the proposal and hereby direct that whenever the Government Departments, Public Undertakings/ Corporations etc., intend to procure Computers and other Office Automation Equipment they should make advance payments to a tune of 90 percent of the estimated cost to the Andhra Pradesh Technology Services Limited

along with the indent and settle the balance of ten percent within sixty days of satisfactory completion of supply of the said equipment.

4. This order issues with the concurrence of the Finance & Planning (Fin. Wing: Expr. GAD) Department vide their U.O.No.P-90-6-03/1173/Expr:GAD/90 dt:06.07.1990.
